	Must submit a Degree Application before the published deadline and meet all

	Degree candidates must enroll in research credits (ANS 7980) in the final term and
_	in the term of the defense. Three credits in Fall/Spring or two credits in Summer.
	Successfully defend and pass the Final Exam*

The qualifying exam, defense and examination of the PhD dissertation is strongly encouraged to be in person with the full committee and student together. If all attendees cannot be present in person together, accommodations can be made providing all attendees are present synchronously and that members questions are asked and answered in real time. The committee Chair and members are responsible for ensuring the academic integrity of the evaluation; ensuring that the student does not receive unauthorized assistance during the evaluation.
